Risk critical / Operational

Herbert and Forcer Protocols

All CFRS personnel are encouraged to promote awareness of these two protocols when engaging with members of the public, particularly during Home Fire Safety Visits or post-incident interactions, where appropriate.

<u>Herbert Protocol</u>: A national safeguarding initiative designed to help locate people living with dementia who may go missing. It involves completing a form with key personal details that can be shared with police to speed up the search process.

Forcer Protocol: A safeguarding initiative designed to help locate missing armed forces veterans, reservists, and serving personnel. It enables the police to quickly access vital information such as medical needs, known risks, and emergency contacts. This information is submitted via the online form in advance by the individual or their carers to support a swift and safe response.

Zurich Motor Insurance – CFRS Road Traffic Accidents

Please read the <u>service Instruction for Driving Service Vehicles</u> for all information/procedures regarding road traffic accidents. Key points are noted below:

Instructions in the event of an accident

You **should**:

- 1. Take names and addresses of all witnesses
- 2. Take vehicle registration of third party (if applicable)
- 3. Take photos where appropriate and safe to do so

- 4. Provide a bump card to the third party (if applicable) a bump card states information to collect from the other driver and details that we provide to the other driver upon the incident taking place. The bump cards will be distributed, once approved, to all vehicles across the service.
- 5. Report the accident using the Motor Claim Form to Tech Services Fleet (CFRSFleet@cumbriafire.gov.uk). Please ensure that the form is filled out promptly and completely, providing as much information as possible regarding the incident.

You should not:

- 1. Admit any liability
- 2. Negotiate or make any agreement with anyone regarding your responsibility for the accident
- 3. Make or offer any payment whatsoever to any third party
- 4. Rejection of a claim without Zurich's agreement may result in court action against you by the other party.

The Breathing Apparatus (BA) Incident Managers Course is designed for any ICL 1 Incident Commander who is responsible for planning, implementation and oversight of BA operations at incidents and/or during training.

The Learning and Development department has been offering Watch Manager (WM) BA Observer places for WMs to attend their shift/stations fire behaviour training course. This will continue to be available and places should be requested via email to FireService.LD@cumbriafire.gov.uk

The BA Incident Managers Course is additional to the aforementioned and will be the first in a continued program of mandatory BA Command Training offered by L&D.

The course is aimed at developing competent, confident commanders to manage BA operations safely and effectively in line with CFRS updating service procedures and National Operational Guidance. The course will be delivered with a combination of theory, table-top and practical elements.

Use of USB devices including USB desk fans

The use of unauthorised USB devices is prohibited within Cumbria Fire & Rescue Service. Unauthorised devices have the potential to facilitate a cyber-attack against our ICT solutions, which would have a devasting impact on operations.

If you are using USB connected devices, ensure they have been approved for use by ICT. Personal USB devices are not authorised for use.

It is everyone's responsibility to comply with this policy and play our part in protecting the Service's ICT systems.

Examples of prohibited USB devices include:

- Desk fans (These can now store malicious software)
- Personal mobile phone charging
- Vape charging
- Desk lights
- Any personal devices that connect via USB
